These letters should be in a **sealed envelope marked confidential** and included in the application package.

Award application and letters of reference must be received no later than Friday, May 5<sup>th</sup>, 2017.

An Award application form is enclosed. If you need more, feel free to copy the original. Lyric Theatre's Education Committee looks forward to receiving applications from students at your school. The application deadline is **May 5<sup>th</sup>**; the Award recipient will be notified by late May and invited to attend Lyric Theatre Company's Board Meeting on June 20<sup>th</sup> to accept the award.
